## About the ACCA Diploma in Accounting and Business

The Diploma in Accounting and Business has been designed and developed to attract learners by providing them with the fundamental knowledge and principles which provides a broad introduction to financial and management accounting.

The Diploma also provides knowledge of business and its operating environment and introduces learners to the core principles of ethics and professionalism through the use of a Foundation in Professionalism case study.

The qualification structure requires candidates who wish to be awarded the globally recognised ACCA Diploma in Accounting and Business to pass the following modules:

- Business and Technology (BT)
- Management Accounting (MA)
- Financial Accounting (FA)
- Foundations in Professionalism (FiP)

This course is open to both those in employment and the unemployed, as well as those returning to work. The DipAB is fully funded under Springboard+, including all relevant ACCA related fees for all learners who meet the national admission eligibility requirements.

## Who is eligible?

- Returners (formerly referred to as Homemakers)
- The unemployed or formerly self employed.
- People in employment

All categories must meet residency (applicants must have been ordinarily resident in an EU/EEA/Swiss state for at least three of the five years preceding their entry requirements to the programme) and nationality requirements.
