The ACCA globally awarded and recognised Advanced Diploma in Accounting and Business programme is aimed at graduates who wish to pursue a career in accounting and finance. The qualification is designed with emphasis on knowledge, skills, professional values and competencies which will prepare capable financial professionals who are able to contribute to all business sectors whilst building successful careers for themselves. The qualification structure requires candidates who wish to be awarded the Advanced Diploma to pass the following modules:

- Performance management (PM)
- Taxation (TX)
- Financial Reporting (FR)
- Audit and Assurance (AA)
- Financial Management (FM)

The course will be primarily delivered online. This course is open to all, regardless of their employment status, provided they meet the minimum academic requirements of having a cognate degree award at Level 8 of the NFQ. The Advanced Diploma in Accounting and Business is 90% funded under HCI Pillar 1 including all relevant ACCA fees with participants or their employer sponsor contributing the remaining 10%.

#### Who is eligible?

- 1. Recent Graduates who hold a Level 8 qualification.
- 2. The employed who hold a Level 8 qualification and wish to upskill or reskill to meet required skill needs across a range of sectors.
- 3. Those in receipt of eligible DEASP payment who hold a Level 8 qualification and may require additional upskilling
- or reskilling in order to re-enter employment.
- 4. Previously self-employed- who hold a Level 8 qualification and may require a new qualification to return to self-
- employment or to enter employment.
- 5. Returners who hold a Level 8 qualification who may require additional upskilling or reskilling in order to re-enter employment.

All categories must meet residency (applicants must have been ordinarily resident in an EU/EEA/Swiss state for at least three of the five years preceding their entry requirements to the programme) and nationality requirements.
