The course addresses the significant demand for risk/compliance professionals, and focuses on the specific areas of skills demanded in an increasingly Fintech driven operating environment.

The course, critically, provides the opportunities for returners to the workforce, and those recently made redundant in the downsizing of the domestic banking sector, with the opportunity to demonstrated work based skills and competencies, and new entrants to the financial services industry.

ACCA POST GRADUATE DIPLOMA IN PROFESSIONAL ACCOUNTANCY (LEVEL 9)

90% FUNDED (WITH HCI)

This programme will provide learners with the knowledge, skills and competencies required to operate within the professional accountancy domain. The programme is specifically focused on the knowledge and skills required to undertake strategic ACCA professional examinations.

The programme offers Accreditation as a Postgraduate Diploma in Professional Accountancy (Level 9 – 60 ECTS) by Technological University Dublin (TU Dublin). The program is also endorsed by ACCA.

DIPLOMA IN FINTECH RISK & COMPLIANCE (LEVEL 7)

90% FUNDED (WITH SPRINGBOARD)

The Diploma in Fintech Risk & Compliance is a level 7 minor award (40 ECTS) and will be delivered by PAT Business School with TU Dublin. TU Dublin will hold responsibility for ensuring academic quality including responsibility for: programme validation; programme boards; exam boards; external examiners; and for ensuring adequate protection of the enrolled learner.



This programme is designed to address industry-wide challenges by providing professional training in Fintech Risk and Compliance. The programme provides participants with the knowledge and skills required to conduct and manage evolving compliance functions within the financial services industry.

The programme will be delivered part-time over one academic year in an on-line environment. The academic year is divided into two semesters, commencing September/December & January/May each year.
